COMPILE NECESSARY DOCUMENTS



PASSPORT : A travel document, issued less than 10 years ago, containing at least two blank pages, with a period of validity at least 3 months longer than the date on which you intend to leave the Schengen Area



TWO IDENTICAL PHOTOS : Not older than six months and Measuring 35 mm across and 45mm in height with head should take up 70–80 per cent of the photo and shoulder should 20–30 with white background.



SOCIO-PROFESSIONAL SITUATION : Letter of introduction stating purpose of visit on company/organisation letterhead paper, signed by competent authority



BUSINESS ACTIVITIES IN FRANCE : INCLUDE A FORMAL INVITATION LETTER FROM THE HOSTING FRENCH COMPANY.



ACCOMMODATION : Reservation of a hotel or a tenancy agreement



TRAVEL INSURANCE : ENSURE COVERAGE OF AT LEAST €30,000 FOR MEDICAL EXPENSES AND REPATRIATION.



FINANCIAL MEANS : Bank statements, pay slips, tax returns & company registration proof



TRAVEL ITINERARY : Reservation of a return ticket or travel itinerary.
